#### **ASF Governance**

- Board of Directors governs the foundation
- Project Management Committees (PMCs) govern the projects
- Board of Directors appoint officers
- Officers of the corporation who set Foundation-wide policies



#### **ASF Board**

- Composed of 9 members
- Yearly members meeting
  - ASF members vote in ASF members
  - Board members voted in by ASF members
- Board members are unpaid volunteers



### What does a board member do?

- Attend monthly board meetings
  - Review officers and project reports
  - Vote on resolutions
- Deal with other issues that arise
- Board F2F



# **Preparing for board reports**

- Shepherds board members get assigned a group of reports
- Whimsey reports
- Agenda tool
- ASF mailing lists



# What should be in a good report?

- Should be accurate
- Community focused
- If needed, contains issues for the board
- All the requested information



# **Reviewing reports – project activity**

- Number of contributors
- Number of commits
- Active and diverse project
- Little or no activity can be fine



## **Reviewing reports – discussions**

- Where are conversations happening?
- Activity on mailing list
- Project open and transparent
- Decisions are being made on the lists
- Vendor neutrality



### **Reviewing reports – release votes**

- Releases and votes done correctly?
- Are release artefacts in line with release and distribution policy?



# **Reviewing reports – private list**

- Voting on new Committers and PMC members
  - Are the discussions and voting on new people done correctly?
  - Is the acceptance bar the same for everyone?
- Are they responding to security reports?
- Are all PMC members subscribed



### **Read the report**

- Does the report meet what I expect expect?
- Is anything missing?
- Is it accurate?
- If needed, flag the report or add a comment
- Go on to the next report



## **Board meetings**

- Time zones are hard!
- Usually 1 hour long
- Most of the work is done outside of meetings
- Accept unflagged reports
- Assign tasks to directors from flagged reports
- Vote on any resolutions
