X. Establish the Apache Sentry Project

WHEREAS, the Board of Directors deems it to be in the best interests of the Foundation and consistent with the Foundation's purpose to establish a Project Management Committee charged with the creation and maintenance of open-source software, for distribution at no charge to the public, related to Fine grained authorization to data and metadata in Hadoop.

RESOLVED, that the office of "Vice President, Apache Sentry" be and hereby is created, the person holding such office to serve at the direction of the Board of Directors as the chair of the Apache Sentry Project, and to have primary responsibility for management of the projects within the scope of responsibility of the Apache Sentry Project; and be it further
